The CEO welcomed the members of the meeting and made detailed presentation on the following projects:

- a) Presentation on projects considered under Silvassa Smart City.
- b) Presentation on Integrated Command & Control and Smart Governance projects.
- c) Presentation on Water Supply Scheme Silvassa.

2.01 Concern was expressed regarding the high elevation of Storm Water Drains in certain areas of the city.

PMC to address these concerns in the storm water drainage DPR & tender.

2.02 Councillors suggested that an alternate location for Vegetable Market be considered, if feasible.

Action Item: PMC to assess alternatives and feasibility and appraise the CEO, SSCL, CO SMC and the SMC council

2.03 The concept of green top over shopping complex was appreciated. It was suggested to have Air conditioned shops, if feasible.

2.04 CO, SMC suggested to install two VMD's near the new SMC building for information dissemination to citizens regarding the SMC & UT Administration activities/projects etc.

Action Item: PMC to include these in the scope of ICCC and Smart solutions tender

2.05 Vice President, SMC, suggested that parking facilities be planned for current and future requirement of the city. CEO and PMC updated that the government site near Kilvani Naka is being considered for MLCP. Councilors expressed their agreement on the site selection and importance of parking solution around Kilvani Naka.

PMC: To complete feasibility study of the site near Kilvani Naka for MLCP.

2.06 Expansion of nearby SMC area for the water supply project was discussed. It was suggested that Samarvarni & Masat to be included in existing Silvassa Water Supply project & Rakholi & Sayali to be excluded.

Action Item: Approval to be sought from MoHUA for execution of projects beyond the SMC boundary and the BoD.

2.07 Vice President, SMC, expressed his reservations on the viability of the IT Park project due to unavailability of necessary infrastructure and resources such as Engineering colleges in the area.

Action Item: PMC to submit the IT park viability assessment at the soonest possible.

2.08 PMC has recommended that Roads with ROW less than 18 m (as per SMC identified list of roads) will not be considered for ducting and the same was appraised to the present members of the meeting.


